## Wimbledon Ballot

- The LTA rules have changed and so has our ballot
  - Only juniors over 11 can opt in
  - No more sign up sheets on the notice board
- Ballot event on Saturday 21 April at 5pm
- All members who opted in for this year are eligible
  - You are still eligible if you do not attend the draw
- If your name is drawn:
  - If present, you can choose from the remaining pairs of tickets
  - You can appoint a proxy to make the choice for you
  - Otherwise you get the next ticket on the list
  - You can return tickets that you do not want but cannot exchange tickets
